PRESIDENT SCHULMAN: (*SOUND OF GAVEL*) Good evening ladies and gentlemen, ah...before we begin I want to welcome ah...the young people from Ulster. It's a pleasure to have you tonight. We will ah...be talking with you later. Also, um...I want to ah say that Don Casar's wife is going to go into the hospital tomorrow for surgery and I know that Don appreciates all our thoughts and prayers with Rita. Finally um...as all of you know a great event occurred in the United States on July 4th, it was not the Declaration of Independence however, it was Mary Cirelli's birthday. (*Laughter*)

CLERK TIMBERLAKE: The Massillon/Canton Ulster Project is an inter-denominational organization working to promote peace in the turbulent region of Northern Ireland. Each year, the Ulster Project brings teenagers from the Greater Belfast area to Stark County to live, work and play with American counterparts for the month of July. This year, 24 teenagers have spent the month in the United States. Local families having a child of similar age, play host to these admirable children. Together, these teens spend a life-changing month learning to see beyond differences in nationality and religion; and Whereas for the past 23 years, the Massillon/Canton Ulster Project has afforded the opportunity to hundreds of Northern Irish youth, the opportunity to make friends from the opposing sides of the existing conflict in their country. Through the generosity of Stark County citizens, these future leaders get a first-hand glimpse of America, the values of freedom, equality, and brotherhood that we, as Americans live by; and Whereas The existing hope is that friendships made and lessons learned in America will make their way back to Northern Ireland, helping to bring harmony and healing to their people in a troubled land. It is our hope that together, we can change history. Ulster Project teens experience opposite faiths here in America in the hope that these experiences will help them relay to their people that hatred is so fruitless. Now, Therefore, Be It Resolved that we, the Members of the Council of the City of Canton, Ohio do hereby go on public record as commending all those involved in the Ulster Project including the Executive Committee, their American host families and the host teens for their endless hard work and dedicated efforts to help building an understanding and friendship between Catholic and Protestant teenagers from Northern Ireland. We further commend our Northern Ireland guests for their vision of a peaceful and democratic nation.

SERVICE DIRECTOR CONCATTO: When Hexagram realized that was ah...this had to be a bid...ah that they still had to go through a performance bond and bid bond procedure ah... that's what increased the price. It's typically ah...a company will include that in their bid, they didn't realize that that had to be included in their bid and so that's what would be the cost of that.

PRESIDENT SCHULMAN: Any other remarks?

MEMBER CARBENIA: Mr. President.

PRESIDENT SCHULMAN: Member Carbenia.

MEMBER CARBENIA: Ah...did they bid against other people on this ah...on this project?

SERVICE DIRECTOR CONCATTO: Mr. President.

SERVICE DIRECTOR CONCATTO: This is considered a sole provider. Ah...It's ah...typical...ah.. The same as like our Motorola. We have a Motorola system ah...and we, only Motorola can bid on that because their the onl...they have the product already in place. Hexagram has this computer project...product in place..ah there for it's realist... I mean there....they become the sole provider to go from analog to digital, was what this bid is about.

MEMBER CASAR: Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: Ah...this is, Service Director again, if I may. This is the same that we ah.. Spoke in...couple weeks ago in regards to the ah...this is for our automatic reading service or whatever. And remember I asked you a question two weeks ago ah...in Caucus, "How much did we pay for that system when ah..ah.. put it in to service the City of Canton?"

SERVICE DIRECTOR CONCATTO: Mr. President.

PRESIDENT SCHULMAN: Director Concatto.

SERVICE DIRECTOR CONCATTO: The entire system in a whole was \$10,622,185.50 and that was done in April of 1998. The network system for which Hexagram was a part of, it was divided up into 4 systems, the project management, meter installation, water meters and the network system. The network system was valued at \$4,680,639.50. That again was provided, part of that contract was provided by Hexagram. That system..ah...included...ah...ah...data collection units and meter transport units. So another words, we now, as you know, we read meters through this system. It sends a signal to a data collection unit which then over a cell phone ah...tells us what the meter reading is. It is presently done in analog and the new system now must be done in digital and that's the cost, that is Hexagram's cost for changing from analog to digital. If I may add ah... Mr. Casar, you did ask about um...problems. Ah...the..in the initial stage of this project, there was some problems

because Hexagram apparently wasn't given the right information but after everything was done after like the first year...um...Then there has been no problem ah..with this system since the first ah... since the first year.

MEMBER CASAR: Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: Per usual, Service Director Concatto, you've done a good job in research and answering the question but one other question I'd like to ask you maybe at this particular time. Have we saved the taxpayers any money that you might know by going to this system or is costing the taxpayers to basically get the same work done?

PRESIDENT SCHULMAN: Director Concatto.

SERVICE DIRECTOR CONCATTO: Yes...ah...I believe we have saved in meter readers. We don't have as many meter readers, um....and also one of the other savings that we've had, before we had this system, in our society today where we have both people working, it was very hard to get in homes. We were probably only getting in to 50% of the homes because of that. So we were able to reduce the number of meter readers we had and we were also able to get a better reading by doing this without having to get into the house since those homes were hard to get into in the first place.

MEMBER CASAR: I... Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: I understand this but we also had ah...the digital outside that we could read the meters where they didn't have to go inside and that was in place just like the gas company has and the electric companies, course theirs is always outside. So that was something that we could have accomplished for a lot less fee and we would have maintained our....our...ah..ah..our ah...persons that walk and read the meter, which is always good. You see people walking around and when they're doing that, they're also providing some type of security for the neighborhood because, you know they see things that are not...that are unusual. And in my opinion, this is my opinion, I think we spent \$10,000,000.00 of taxpayers money that I don't think we could really justify it.

PRESIDENT SCHULMAN: Director Concatto.

SERVICE DIRECTOR CONCATTO: Mr. President, um...I can only say that, if you're asking me did we ah..did we pay back the \$10,000,000.00 by a savings, I can't quantify that to say that we have...ah..again, this project has been in place for 10 years. Hopefully maybe over the next 10 or 15 or 20 years that it will. Um... none of us, well I wasn't here when this was put in place. I'm not sure if you were Mr. Casar.

MEMBER CASAR: I wasn't either.

SERVICE DIRECTOR CONCATTO: I'm almost assuming that but the fact still remains that we do have a...a...\$10,000,000.00 project out there, whether we think it's valuable or not, I...I...it's still in place and I believe this is wise money to spend to keep it in place ah...since we already have the investment.

I am going to assume that it was bid out 10 years ago.

MEMBER KRAUS: Then there was no additional bidding or anything for the additional money? It was just needed to be as part of the original to...ah to update, the extra money?

SERVICE DIRECTOR CONCATTO: Mr. President.

PRESIDENT SCHULMAN: Director.

SERVICE DIRECTOR CONCATTO: The...the..what you're voting on this evening is the additional cost to go from an analog to digital system with Hexagram who already put this \$ 4.7 million in the network system in place.

PRESIDENT SCHULMAN: Are there any other remarks?

MEMBER CASAR: Mr. President.

PRESIDENT SCHULMAN: Member Casar.

MEMBER CASAR: We're going to go from analog to digital and you know that digital ah...is probably going to be out there for a couple years and they be coming back with whatever it is and we're going to be spending another couple hundred thousand dollars.

If you don't agree with that, I would vote the main ordinance down but I...I would hope that the amendment would pass and then the main ordinance would be ah..based on how you feel.

MEMBER WEST: My underst..... Mr. President.

PRESIDENT SCHULMAN: Member West.

MEMBER WEST: My understanding is, they bid on this at \$171,600.00 and \$85,800.00, correct? And since they bid on that shouldn't that not be the.....

SERVICE DIRECTOR CONCATTO: I'm sorry. The..the \$85,800.00 is being changed to \$87,516.00 to equal and it's coming out of two funds so it's done twice. It's coming out of the water billing fund and the sewer billing fund. Those two numbers will equal the \$175,032.00. For those of you who have not spoken, we appreciate your coming down and giving us ah..your opinions or complaints or comments. I would just like to remind all the speakers that City Council has adopted a rule limiting the public speaks to 3 minutes and ah...I don't mean to cut you off, I will try to give you a heads

up when you get close to the 3 minutes but if you would follow that rule, we'd be most appreciative. Our first speaker, and again, I apologize ah... sometimes I am unable to read the handwriting, it's not your fault, it's mine. David Marxmiller. Mr. Marxmiller. Mr. Marxmiller? The next speaker is Walter Hood, Mr. Hood. And Mr. Hood would you give us your name please and your residential address?

WALTER HOOD: Walter L. Hood, 316 Freedom Avenue, NE, Canton, Ohio 44704, in the great City of Canton, Ohio. Thank you.

PRESIDENT SCHULMAN: Good evening Mr. Hood.

WALTER HOOD: I was here a few weeks ago about parking on both sides of the street that I live on from 3rd Street NE to 4th Street NE and then June the 15th, there was a terrible accident on that same street. Coming from 4th Street, heading toward East Tusc., cars parked on the one side going south was good but as the gentleman got to the crest of the hill, there was cars parked on the east side of the street also and he couldn't straighten his little pick-up truck up, he crashed into 1 car, 1 truck, tore half of my yard up and tore up my son's car sitting in my driveway. And it's like this: cars were here, he's had a good shot...he was drinking, true enough but when you got down here, you have cars here, cars here and the street was smaller and he couldn't control his vehicle. And if he wouldn't have hit my son's automobile parked in my driveway, my neighbor, his truck probably would be in my neighbor's, imbedded in the back of his house by now. That's all I got to say. But I would like to know if they gonna be anything can be done about that.

PRESIDENT SCHULMAN: Thank you Mr. Hood. And as I've always said, if you want to discuss anything with the Administration, Members of Council, myself, feel free to stay until after the meeting and we'll try to answer those questions. Thank you. Our next speaker is Katherine Baylock. Ms. Baylock, good evening, if you would give us your name please and your residential address, we'd appreciate it.

KATHERINE BAYLOCK: Live it ah...my name is Kathy Baylock, I live at 325 Cornelia Ave NE, Canton, Ohio.

PRESIDENT SCHULMAN: Good Evening.

KATHERINE BAYLOCK: And I came in to speak our street once again. Um...Freedom, Henre...Freedom, Cornelia, Henrietta, I mean on down the road here, parallel to each other, northeast. Ah..we were here over 2 years ago and those streets have not been touched and we have pictures of the streets with the craters and the cracks in 'em, as deep as coming to your ankle in the middle of the street. And I'm here because I want to know why aren't anybody doing anything about it. That's what I would really like to know. I mean, I almost laughed that I had to come up here again because of the neighbors where I live at but nothings been done, it's like we're not even coming here addressing the issue with you about the streets. And they look terrible and I'm sure where everybody lives in here their street doesn't look like those streets. We have pictures of the streets, you should see 'em their terrible. And we would like them to be fixed. I mean, that's not asking much, to fix our streets. We live in America, we live in the City of the Pro Football Hall of Fame City on the other side of the tracks and the streets need to be fixed. They're terrible. So I'm comin' here again with some of my other neighbors asking you to look at our streets and fix 'em.

PRESIDENT SCHULMAN: Thank you very much and as I told Mr. Hood, if you ah...would stick around afterwards and talk to the Administration and talk to Councilmembers, I'm sure we can try to help you as much as we can. Thank you Ms. Baylock. Our next speaker is either Ms. or Mr. Bodnar and I apol...oh I know, I'm

sorry, did you make a mistake here on your first name? Who wrote that? Oh see that's the problem. Good evening, I'm sorry.

PAT BODNAR: She just calls me sweetie. My name is Pat Bodnar, I live at 824 High Ave SW, across the street from the Pastime Inn. I live with Susan, who you've become familiar with in the last couple meetings and she also gained a little bit of notoriety this weekend with an article that was in the paper. If you watched the video, you'll probably see one of the reasons why I truly love that woman. I truly do. I passed out a DVD that I put together of incidents that have happened outside this bar. Okay, there's probably 14 or 15 of them. All but 1 of them has happened since this place has got it's license revoked, okay. Four of them have happened since the last meeting that we've had here, okay. All of them are after midnight, most of them are after closing. I don't understand how this blood sucker from Bolivar cannot be held accountable for the animals that he throws out on our street. I don't understand it, okay. The other things is why we have to wait for some nameless, faceless bureaucrat from Columbus to clean up a situation that's happening 10 blocks from here. It's at 9th and High, 10 blocks. Thanks.

PRESIDENT SCHULMAN: Thank you, sir. And believe me, we hear you loud and clear. Ah...our next speaker is Susan Seiler and Susan, you've spoken before. Good evening, would you give us your name and your residential address just for our record here.

SUSAN SEILER: It's Susan Seiler, I live at 824 High SW. I want to thank Ed Balint for putting our story out there but I think you guys all know our story and President Schulman, this is my farewell address because hopefully, we looked at a beautiful property in Canton Township tonight. If the financing goes through, we'll cross our fingers, we'll be moving soon. So Mayor, I want you to think of us next time you say, you don't have to move to live in a better neighborhood because yes you do. That bar was clo...it's liquor license was pulled over a year and a half ago. Um...under the nuisance abatement law it could, you could go in and get a temporary restraining order, which would close it during the appeal process. Um...it has been progressively getting worse, ah...on the CD, and those were Patty's favorites that he put on there and there's only about 10 but those are from the last um...month and a half of our life. Um...a week and..a week ago, there's three of 'em peeing on my house and it took every bit of restrain I had not to take my mace out and put it out the window and mace those people. One of 'em pees on my... on the stump of my flowers and two of 'em laugh as they pass a joint and he says "Wait a minute, don't pass me the joint, I'm pissin' on somebodies house." This is what they do. Saturday night, the story ran Saturday and we thought we could tell that there was something in the air. There was people waiting outside the Pastime at 2:00, we called the police about 2:10 a riot erupted. And we thought, how vain of us, we thought that they were coming to get us. We were scared. There was a huge fight inside the bar, which 50 people spilled out into the street, okay. We called the police again and they were there within about 4 minutes. Um...it's just...it's just unbelievable that nothing can be done. That this can't be closed down. A week before, the police department has started helping us out by ticketing cars on the sidewalk. That night they found 2 of the cars that were on the sidewalk, they had warrants out for 'em. And they caught a 17 year old in the bar drinking. Oh no, they didn't catch her drinking, they weren't quick enough. They caught her in the bar unsupervised. Satu....or Friday night, this last Friday night there was a 19 year old standing outside bragging because she likes drinking at that bar because they don't check her I.D. That's all it would take to shut 'em down. Underage drinking and they can have that place closed in 10 day, that's proof what they need to shut that place down and get a restraining order. But I'm done, I've done everything the Mayor has told us to do, we've called the drug task force, we've called the tip line, we've video taped, we've done everything that we possibly can. So we are moving to a better neighborhood and um, you're done with me, I'm done with you guys. But um...I'm sure you're probably going whew...thank goodness. But it had over 4,000 hits on the national website, blog did, Ed Balint, did you see that? That was wonderful. So now the media is out there so I'm not the only one with a black eye anymore. Shame on you guys, you guys now have

a black eye too.

PRESIDENT SCHULMAN: Thank you very much.

(APPLAUSE)

PRESIDENT SCHULMAN: And I'm sure if you stick around, there'll probably be some comments in the miscellaneous, if you would. Well we appreciate by the way, you're coming down all these times. Our next speaker is Henry Mack. Mr. Mack, if you'll give us ah...your name and residential address sir. And good evening.

HENRY MACK: My name is Henry Mack. I live at 2430 4th St NE. Proud neighbor there. I've been in Canton all my life and I've been at that address for 45 years. I came here to talk to the board, maybe somebody can tell me, give me advise. We have been up about our streets in that neighborhood. When I say those streets, I mean from Freedom Avenue, Cornelia, Henrietta and Fenton, from 3rd Street to Georgetown. We're running the streets...ah north and south. Now the City of Canton just placed, 2 years ago, 1.3 million on 4th St, new drains and everything. They did a beautiful job. I don't know whose responsible but whoever it is, I salute. But the streets going the other way, we've been promised for the last 3 years that some things going to be done, It's gonna be paved. There's a Chinese philosopher said that a picture is worth a thousand words. I brought some pictures here and I don't know how you want me to do this. Do you want me to present them to you sir?

PRESIDENT SCHULMAN: Sure that would be fine and then we'll pass them out. Absolutely. Thank you sir. Thanks Mr. Mack.

HENRY MACK: Those pictures will give you an idea of what we're facing. The group here with me present, the group in that neighborhood. We love our property, we love our neighborhood. We love our town. We have noticed that, I don't know, here in the past that we've been overlooked on the streets. Just found out last week that we were overlooked again on them streets being repaired. And we hope that the Mayor, Mr. Hunt, Safety Director, or whoever has pro...that can direct us to getting these streets repaired and repaired correctly. I understand from some of the old timers, in which I'm considered one of the old timers, it's been over 40 years since these streets been paved. The asphalts coming up, the wholes are deep, they've been patched on top of patches on top patches on top of patches. Ah...the street department was out there Fri...Thursday and Friday and they only put a little asphalt in part of the holes, not the whole complete hole and never came back to repair. Today is Monday. Um...that's 1 concern, the other concern is signs. We have ss...we used to have a lot of signs out, speed limit signs. They're gone. Uh...we had ah...no parking so many feet from East Tusc., they're gone. We had signs, we're right on the border of the City Limits where you come into Canton on East Tusc. We used to have signs up there saying how great Canton is, they're gone.

PRESIDENT SCHULMAN: You have about 10 seconds.

HENRY MACK: So we...those are our concerns out there. Anybody on this board can help us, talk to us or ah...direct us to the correct person or persons, we would be very glad.

PRESIDENT SCHULMAN: Great thank you sir very much.

HENRY MACK: Again, I thank you.

PRESIDENT SCHULMAN: And Mr. Mack, as I've told everyone, we will stick around after Council and I know the Mayor and her Administration will be here for you. Thank you very much for coming.

(APPLAUSE)

PRESIDENT SCHULMAN: Our last speaker tonight is ah...Preston Young. Preston Young, good evening sir. Would step forward to the microphone and give us your name and residential address please.

PRESTON YOUNG: My name is Preston Young. I live at 361 Freedom Avenue NE in Canton. Ah...I'm sure you remember me being here a couple meetings or so ago on the same item. I won't take up a lot of time because I gotta meet with somebody after. But I would like to say ah...what we have here is ah...(inaudible)...or it's ah...one of those things that maybe they try to satisfy you by coming out and half patch and go. See what happened the last time was we had problems so they just showed up a couple days ago to kinda sweep the street which is a waste I told ya's onest you see those pictures. When you sweep all your sweeping up is the ah... the gravel and the slag outta the asphalt. Ah...that stuff when it get hot (inaudible)... And ah...it's so much to be done out there, we need to send somebody out there and we walk it with ya and show you where the problems are. It's been a ongoing problem for years because ah...when..I..I..been there since 1960, we build in 1960. That section of ah...Freedom Ave wasn't developed. It was just developed to the crest of the hill to the south with the little bungalow. And there a couple a 1, 2, 3 older homes on the ah...east side but the west side (inaudible) wasn't developed. Just...just a wooded area (inaudible) and all that whole area was developed with new homes. I had a problem at the crest of the hill with a...with a water problem. Once they came out, I was there 2 years, '60, '61, '62, they came out and resurfaced. Well what they did, they raised it too high so I get water on my front lawn. When...in the winter it would freeze, snow (inaudible). So I was spending money year around one way or the other ya know, trying to keep it going. Though, they finally came out, put a small asphalt oval like curb along the (inaudible) water. But on a real downpour see on my side, on the west side, where the east side houses elevated so it runs down from driveways over there, right across my property. So what I did, I got tired of that so I went ahead and raised my lawn up..up front, you know, raised it up to slop down to the curb side. So that put a little...that gave me a break. But they, every winter the guy would come around with the snow plow because they just ran it just past my driveway. Every winter you come along with the snow plow and you plow that curb up in that section of the driveway. So they did that 3 times, I got sick a that so I ah...(inaudible) it in and had a guy come out and asphalt (inaudible) you know like the little bump type things. That's right across my driveway now. I put that in, so I been concerned about gettin' the resurface, because I'm gonna have to do somethin' with that. But I'll meet with the group here. Those are the kinda concerns we have and we was promised by the Council...the Council Representative that we would be resurfaced in '07 but understand we're not.

PRESIDENT SCHULMAN: Very good. Thank you very much Mr. Young and thank you all for ah..coming down. Is there ah...a Dave Marxmiller here? Alright. That concludes ah...the public speaks portion of the Council meeting.

MISCELLANEOUS BUSINESS

PRESIDENT SCHULMAN: Ah, we're now under Miscellaneous Business, is there any miscellaneous business?

MEMBER ZACHARY: Mr. President.

PRESIDENT SCHULMAN: Member Zachary.

MEMBER ZACHARY: I am going to take the liberty tonight to go on record, on public record to say is it any wonder why the residents of the 4th Ward feel that they are under served? For the past 3 ½ years, I've fought, I've screamed, I've pulled my hair out and I've gained a whole bunch of new gray hairs to prove it about the very issues that they are here talking about tonight. Pat, it's been more than a couple of months that you guys have been coming down. I've been working with them for 3 years to get the Pastime Inn closed. Through Affairs of Community Group for 3 ½ years to get streets paved or to even have someone say "This street deserves to be paved." I am very upset about the fact that people still have to come to Council to complain about the same things when I have passed their concerns along and it seems like they're not a priority. Ward 4 never seems to be a priority in the City of Canton for some reason. I do have great news which I will share with you in a minute. However, I would like to have a meeting, whether it's with Joe, the Chief of Staff, the Safety Director and the Mayor to help the people who are here tonight and I know that interest reins and...and it comes and goes and they're here tonight so we need to address the concerns because they're not just concerns that popped up over night. They've been coming down here for quite sometime. And they deserve the respect that every other constituent in this City gets. *(Applause)* On another note, you may recall um...ah...Ms. Betz who came down, she unfortunately, her house was broken into and her 80/90 year old mother was hit and they were robbed with quite a substantial sum of money and the guy was stuck in the house. She called and left me a message the other day and said "Kelly, praise God, they caught him." And they caught this mental giant because he robbed someone else and beat them up and happened to leave DNA at the scene and stole a guys car, so I want to commend our police department for doing a great job...ah...Ms. Beck certainly feels a lot safer as well as her mother and ah... we got one nasty guy whose gonna go away for a long time. So I thought I'd share that because I know there's a lot of complaints that come from my area but we also like to give credit where credit is due as well. Thank you. *(Applause)*

PRESIDENT SCHULMAN: Thank you Member Zachary.

MEMBER CIRELLI: Mr. President.

PRESIDENT SCHULMAN: Member Cirelli.

MEMBER CIRELLI: Ah thank you Mr. President. Um...I have comments over the 4th of July, the fact that it was my birthday, I'm not really looking forward to any more of them because of the fact I have with me as evidence, it started in my area on the 3rd, 4th, 5th, and 6th of July with fireworks. Now I know the State, and I see someone in the audience tonight that's with the State Legislature, they say that they can sell the fireworks but they have to sign a paper that says they have to take them out of State when everybody knows that when they purchase those fireworks, when you look at all the cars, they have Ohio plates on them. And then they leave it to Ohio communities to enforce a law that is unenforceable. My son was a 911 dispatcher and as he said "Mom, it's like trying to control the weather." Because he knows what those calls are like. On the same note, I have to compliment the Mayor, I had already spoke with Chief McKimm and um...Mr. Hunt. I want to compliment them on what the officers who had to come to a, what everybody thought was a nice neighborhood because of one rental property that is a duplex. The people living on the one side were held hostage, they're an older couple by a ah...group of two-legged animals, vicious animals that had a group of other vicious animals with them. The one gentleman had the nerve as the officers were pulling up to even kneel down and light it right in front of the truck, ah...the lights of the police car. The officers were very professional. You couldn't have asked for a nicer response. But they had to put up with was absolutely disgusting. They were demeaned, they were talked down to, there was an arrest happening that ah...just because one of the people was so arrogant and wouldn't even divulge his name or give them any form of identification. So I have to compliment the Mayor and I did already speak with the Chief

on that because those men really took a lot of kicks in the head and um...I have to applaud our officers for what they tolerated. And it was happening all over because then the next day, my phone, phones....my cell phone and my other phone...ah...people that tried to get to me that were in the family could not get through to me because my lines were busy from people all over the City of Canton because of these fireworks. So you if the Legislator is going to pass a law, they better put the bucks with the money. I've been down there and I know at that time we were in the minority and my party is still in the minority but with the Governor there, I would think they would have some clout. So I hope that particular Legislator will take this back to the Administration there and ask them to...if you're going to have a law look at the effect it's going to have on the local communities and like I said, I have evidence that just what I cleaned up in my area. And this is also one of these rocket things, whatever...that burnt the house in Massillon and it was very dry. I was out there with my garden hose, trying to prevent as much as I possibly could. One of the neighbors came home, asked the gentleman if he would stop until she could get her baby and her little girl in the house. He fired one right at her and that's when I went in the house and called the police because that was assault. But it was a God awful mess and it ah...I don't know what we can do but like I said to the Mayor, our officers have to be commended for what they put up with. So I do want to thank them for that and just apprise everybody of the situation. It was absolutely horrendous all over the City. So thank you very much.

Number two, I met with the Law Department today about the fireworks because I too had calls. Um...we have some ideas um...so we're already on that. Number three, Councilman Prater, congratulations to your daughter on being on the front page of the Canton Quarterly in case you hadn't noticed that that was Terry's daughter. (*Applause*) And number four, we were all so proud when the Quarry came into the City of Canton and they've brought a great addition to Ward 4 to add to an even greater Ward but coming on board, when the Quarry opened, they called and asked um...if we had any suggestions on different organizations that they could make a donation. On their first weekend of being opened, they collected their greens fees and since I'm not a golfer, I don't know how much it is um...but they gave a portion....too much??? No...They gave a portion of each of their green fees to two organization that tonight, with your permission Mr. President I would like them to come forward...uh..the two that I'm recognizing tonight, there is a third one, but the two that they've ask me to present the checks to tonight would be Hammer and Nails of Stark County, represented tonight by Darlene Leghart (*Applause*), Chet Werren, representing Primetime Basketball (*Applause*) the third donation went to the First Tee and I'm happy to share that each organization got \$1,600.00.
