PUBLIC SPEAKS (OPEN FORUM--CITY BUSINESS ONLY)

PRESIDENT SCHULMAN: We are now under Public Speaks and Open Forum, and we have four speakers signed up tonight. I would again ask each of you to please keep it down to three minutes, particularly a lot of the fact that I have to get up at 5:30 tomorrow to do a voter protection, so I want a good night's sleep. Our first speaker is Jason Scaglione. Jason, good evening, if you will give us your name and your residential address, please.

JASON SCAGLIONE: Good evening Council. My name is Jason Scaglione. I reside at 3027 Glen Place here in Canton, OH. I am here today to address a proposed legislation on outdoor wood burning appliances. I've talked with many of my neighbors and we view this legislation very disturbing. I personally think the proposed legislation as it is written, is unacceptable. All of us know the energy crisis and the continued push to rely on alternative fuels. This legislation in my opinion, hinders a proposed, the people's right to methods in which they heat their home. I view this legislation to be a way for the City of Canton to eventually ban wood burning altogether as this progresses. I think alternative fuels and the choice in how we heat our homes is very important. If we could all think back to Hurricane Ike that came through, just this year, there were a large number of trees that had been knocked down and were everywhere. This disaster created a big cleanup and sometimes costly for home owners. This might have been much cheaper if people were heating with wood and they would want that wood and would clean it up for free. I am sure that there are people in this city here that have fireplaces. Are we next going to propose that nobody can use their fireplace or wood burning stove inside the house? I think the issue here is that somebody has been upset by somebody's outdoor burning of wood. It is disturbing to me that the city is now looking at what would be basically a ban on wood burning instead of addressing the issue of a nuisance smoke being created by just one or two of these outdoor wood burning boilers. With these homeowners creating the nuisance, I also believe that this infringes on people's choice in how they heat their homes. I would like to know, are there outdoor boilers or wood burning appliances that are put, are these put into use in accordance with the current city code, when they were installed? And are they burning the appropriate fuel or wood. If even one of us, if each one of us had one of these, how would we feel when the city put a ban on us heating our homes. I think this proposed legislation is way too vague and should be looked at long and hard. I would also like to know what the people of Canton think about this issue. I think that this could effect as many as, so many that residents should have to vote on this as a whole and that this should be not just decided for them. I would love to see, I would love to talk with the Repository, our local papers, and see them publish an article and gather some thoughts from residents before this is considered. Thank you.

LEON COTE: Good evening, Mr. President. My name is Leon M. Cote and I live at 1225 41st St NW in the City of Canton.

LEON COTE: Mr. Mayor, Mr. President, members of the Council, and members of the Administration. I am here to thank Mr. Casar for being a forward thinker. For the past six months a lot of us have had trouble getting into the Caucus room to hear our city in action. I think you deserve a pat on the back because the only person that can move it out here is the Mr. Casar, the Majority Leader and I hope you go down like Mr. Capestraint for the three minute public speak in the history and the annals of the City Council that you took the politics out of the back room and brought it out into the Chambers where we can all hear. Thank you very much.

MEMBER CASAR: Mr. President, I would just like to say I have to give credit where credit is due. It was our Clerk's idea.
