**EXAM:** Immediately following candidate check-in  
**LOCATION:** Canton Memorial Civic Center, McKinley Room, 1101 Market Ave. N., Canton, OH 44702  
**SCOPE:** A written examination will be administered covering the following areas: Safety, Mathematics, Mechanical, Comprehension, General Labor Knowledge, Public Relations and other related areas. A 70% passing point will be used.

### GENERAL REQUIREMENTS FOR ANY OF THE POSITIONS ABOVE

All applicants must meet the following criteria: Graduation from high school or G.E.D. equivalent, must possess a valid commercial driver's license at all times, have no felony convictions and must be a U.S. Citizen or have legally declared their intention of becoming a U.S. Citizen. Also, all applicants receiving a conditional offer of employment must pass a functional capacity evaluation to measure physical abilities and pass a drug screen.

### \*\*\*NOTICE OF DRUG TESTING REQUIREMENT\*\*\*\*

Candidates must submit to a drug screen examination. Eligibility of employment shall not be considered final until drug testing has been successfully completed with a negative result. "Drug" means a controlled substance as defined by Chapter 3719 of the Ohio Revised Code, entitled "Controlled Substances", and/or Section 202, Schedules I through V of the Federal Controlled Substance Act, including but not limited to marijuana, hashish, "Crack", cocaine, heroin, morphine, codeine, opiates, amphetamines, "ice" barbiturates, and hallucinogens.

**SPECIFIC REQUIREMENTS FOR UTILITY OPERATOR 2 & UTILITY OPERATOR 2/  
SEMI-SKILLED LABORER**

In addition to meeting the general requirements, persons eligible for these positions must possess at least a valid Class "B" Commercial Driver's License at all times, have documented experience with a private construction firm (documentation to be included with application) and have experience operating a one-ton truck, 5 and 10-ton dump truck, forklift, tractor, loader, skid loader, dumpster, tractor, all grass mowing equipment and jackhammer.

**SPECIFIC REQUIREMENTS FOR UTILITY OPERATOR 3**

In addition to meeting the general requirements, persons eligible for this position must possess a valid Class "A" Commercial Driver's License with Tank Endorsement at all times, have documented experience with a private construction firm (documentation to be included with application) and have experience operating one-ton truck, 5-ton dump truck, forklift, skid loader, dumpster, tractor, loader, roller, flusher (or Vactor), sewer jet truck, ability to work in confined space entry, ability to perform masonry duties, pipe repair, manhole and catch basic reconstruction duties, ability to operate laser/level equipment.

**SPECIFIC REQUIREMENTS FOR SEMI-SKILLED UTILITY WORKER**

In addition to meeting the general requirements, persons eligible for this position must possess a valid Class "A" Commercial Driver's License at all times, have experience operating a one-ton truck, large dump truck, forklift, dumpster, tractor, loader, have the ability to operate various equipment including a jackhammer, the ability to install, maintain and repair water lines, have the ability to install and finish concrete sidewalks, curbs and gutters, ability to climb in and out of an excavation.

**\*\*\*\*IMPORTANT NOTICE TO VETERANS\*\*\*\***

Upon receiving a passing score, a twenty (20%) percent bonus will be granted to individuals who have been honorably discharged from the uniformed services or transferred to the reserve with the evidence of satisfactory service, and who is a resident of this state and any member of the national guard or reserve component of the armed forces of the United States who has completed more than 180 days of the active duty service. (ORC 124.23C) Applicant must submit a certificate of service or honorable discharge (Form DD214) long version before the deadline of February 6, 2013 to receive the bonus credit. Applicants are solely responsible for making Commission staff members aware of previous filings of discharge papers if bonus credit is to be claimed.

**CITY RESIDENCY BONUS**

Applicants who have resided within the Canton City limits for at least six (6) months or longer immediately prior to testing will receive 5% additional credit, provided they make a passing score.

**THE MAXIMUM ALLOWABLE BONUS POINT AWARD IS 20%.**

**EQUAL EMPLOYMENT**

All qualified applicants will receive consideration for appointment without regard to race, religion, color, national origin, sex, political affiliation, age, type of disability, or any other non-merit factor.

**ADMITTANCE TO EXAMINATION - IDENTIFICATION REQUIRED**

Candidates who have been accepted to the examination will be admitted to the test site only upon presentation of their valid State of Ohio Driver's License or other valid photo identification card satisfactory to the examiners. **PERSONS UNABLE TO PRESENT POSITIVE PHOTO IDENTIFICATION WILL NOT BE EXAMINED.**

**RATING**

Upon completion of the examination process, candidates who receive a passing score will be placed on the list of eligibles in accordance with their score. Although this will be one eligibility list for several different positions, you will only be certified as eligible for the positions that you are qualified for.

**DUTIES**

The duties of these positions will vary somewhat depending on the position and/or department, however, general duties will include operation of various City vehicles and the operation of mechanical construction equipment and manual labor as necessary and as designated by supervisor.
