OLD BUSINESS (PUBLIC SPEAKS): None

PUBLIC SPEAKS (CITY BUSINESS): Laura Simon said that 14 months ago she opposed the sale of the Cirelli Building to SMHA. She proposed the property be re-purposed as a dog park for the residents of the city of Canton. Kim Bell said the Mayor has played “musical chairs” with his various positions in the city. She plans to run against him and hopes he will mentor her. She reiterated the issues that she’s spoken about in previous meetings and said nothing has been done about them. Ida Ross Freeman complained that the rental property next to hers is a “trap” house. There was a raid at the property last week but the tenant who is usually there every day selling drugs, wasn’t home. She thinks he was warned of the raid and also thinks there’s an ordinance stating that a landlord can be charged criminally for renting to tenants who commit crimes in the neighborhood. Kim Justice said she’s being harassed by her juvenile neighbor, who is on parole. She spoke to the police but were told that the family was moving. The family did move; however, the juvenile has returned, is squatting in his old house and continues to harass her every day. Cliffie Davis mentioned that a committee she serves on is seeking to bring together all organizations in the city to give away free backpacks and schools supplies to the city’s youth. She’s asked the city of Canton for support. She also asked what was being done with the Cares Act funds that the city received because she hasn’t heard an announcement of plans for a Summer Camp or Summer employment.

MISCELLANEOUS BUSINESS: Mayor Bernabei said he would give Deputy Mayor Williams an opportunity to address Ms. Davis' concerns about the funds from the Cares Act and how they'll be used for the youth camp and employment programs. He also mentioned that the city is waiting to receive ARP Funds in approximately 30 days. Deputy Mayor Williams said they're working with partners to roll out the summer camp programs. He listed a number of partnerships and programs such as Enrichment, Camp 707, Eric Snow YMCA, etc. that will have programs for over 500 youth. The youth will be permitted to do enter a School Credit Recovery Program and an Academic Assistance Program for school and then be transferred to a local employer for real life, practical experience. Majority Leader Smuckler asked how the word is getting out and how many youths will be employed. Deputy Mayor Williams said the various agencies have had no problem in getting the word out to the young people and they will be able to employment approximately 100 youth. Member Hall asked if they can make sure that the summer help employees are residents of the city of Canton. He also requested a list of those who have received funding. Member Kimbrough asked for a report of how the Park Levy monies have been spent. Mayor Bernabei said they are required to report to the Secretary of State so he will make sure she receives a copy of the year to date report and a copy of the 2016 report. President Sherer mentioned that he met with JR Rinaldi (Building Code), Matt Bailey (Planning), and Kelly Parker (Law) regarding numerous complaints of people parking in yards and on sidewalks. Chief Angelo has established a task force to handle these issues and has requested that everyone use See Click Fix for reporting. This will allow his department to have a paper trail on the issues. The turnaround time will be within 24 to 48 hours. President Sherer also asked that we continue to keep Member Fisher in our prayers as he has had a tough time these last 2 years.
