**Public Realm Reinvestment Program**

The Public Realm Reinvestment Program (PRRP) assists commercial/retail properties within the Downtown Canton Special Improvement District, the cities B5 Central Business District and target investment zones (Pedestrian/Urban Form Overlay Districts) located within the Downtown Core Targeted Investment Area and major corridors; as identified in the City's adopted Comprehensive Plan. The program provides matching reimbursement grants to help fund the rehabilitation/renovation of the public realm - the public spaces immediately adjacent to privately owned real property that have shared use and are accessible by both patrons of business or the general public by providing a 50% rebate, up to \$25,000 on eligible expenses. (*Ordinance No. 27/2023. 148/2022*)
